## Terms of Service

Terms of Service Last Updated: 06 October 2023

- **1. Introduction** Welcome to the ARt platform ("we", "our", or "us"). These Terms of Service ("Terms") govern your use of the https://show3d.art website, applications, and other products and services ("Services").
- **2. Acceptance of Terms** By accessing or using our Services, you agree to be bound by these Terms and our Privacy Policy. If you do not agree to these Terms, you may not access or use our Services.
- **3. Eligibility** You must be at least 13 years old to use our Services, or such greater age required in your country to register for or use our Services.
- **4. User Accounts** To use certain features of our Services, you may need to create an account. You are responsible for safeguarding your account and for any activities or actions under your account.
- **5. User Content** You retain your rights to any content you submit, post or display on or through our Services.  Content that is threatening, harassing, bullying, discriminatory, or promotes hatred against individuals or groups based on attributes such as race, religion, gender, nationality, disability, or sexual orientation.

## 6. Misinformation or Deceptive Practices:

o Content that misleads, deceives, or promotes fraudulent or dubious claims.

## 7. Sexually Explicit Content:

Pornographic material or content that is otherwise sexually explicit.

## 8. Spam, Malware, and Phishing:

- Content that is spammy or contains or links to malware, viruses, or other harmful software.
- Content that engages in phishing or attempts to collect personal information in a deceptive manner.

## 9. Impersonation:

• Content that impersonates others in a misleading or deceptive manner.

#### 10. Commercial Misuse:

 Using the platform for unauthorized commercial activities, such as advertising or solicitation.

## 11. Manipulated Media:

 Content that has been altered in a way that could mislead or cause harm, such as deepfakes or other manipulated media.

- Any attempt to interfere with, hack into, or decipher any transmissions to or from the servers running the application.

**9. Dispute Resolution** *Governing Law*: These Terms and the relationship between you and ARt shall be governed in accordance with the laws of New South Wales, Australia without regard to its conflict of law provisions.

Agreement to Arbitrate: You and ARt agree to resolve any disputes through final and binding arbitration, rather than in court, except for claims arising from bodily injury. The arbitration will be conducted by the Australian Centre for International Commercial Arbitration under its rules. The arbitration will be held in Sydney, Australia or any other location we agree to.

No Class Actions: You may only resolve disputes with us on an individual basis and may not bring a claim as a plaintiff or a class member in a class, consolidated, or representative action.

Judicial Forum for Disputes: In the event that the agreement to arbitrate is found not to apply to you or your claim, you and ARt agree that any judicial proceeding will be brought in the federal or state courts of New South Wales, Australia. Both you and ARt consent to venue and personal jurisdiction there.

Time Limitation on Claims: You agree that any claim you may have arising out of or related to your relationship with ARt must be filed within one year after such claim arose; otherwise, your claim is permanently barred.

**10. Limitation of Liability** To the maximum extent permitted by applicable law, in no event shall ARt, its affiliates, directors, employees, or licensors be liable for any direct, indirect, punitive, incidental, special, consequential, or exemplary damages, including without limitation damages for loss of profits, goodwill, use, data, or other intangible losses, arising out of or relating to the use of, or inability to use, this service.
